<b>November 27, 2023 - Rep. Council Mtg</b>	NECC will announce candidate names running for PGCEA President, Vice-President and Board of Directors.
<b>December 2023/January 2024 (TBA)</b>	<p>Candidate Speeches: Three (3) min to speak at Rep Council.</p> <p>Speeches will be posted on the website within 5 business days.</p>
<b>January 12, 2024 (Friday)</b>	<p>The final slate of candidates will be announced by NECC on the PGCEA Website.</p> <p>All Candidate bios and photos will be posted on the PGCEA Website and published in The Educator (PGCEA).</p> <p>Final Spreadsheets must be provided to Elections America.</p> <p>Candidates may now begin campaigning.  <b>All flyers for a PGCEA Office must be <u>approved</u> by NECC.</b></p>
<b>January 2024 (TBA)</b>	Membership applications must be in PGCEA office by cut-off date for new members to be eligible to vote.

<b>January 2024 (TBA)</b>	The NECC will review and test e-ballot. (TBA Election America)
<b>January 17-19, 2024</b>	The Educator and flyers will be <b>emailed</b> to Building Reps to post in work locations.  <b>The Educator</b> and flyers will also be emailed to all voting members via their personal email addresses on file with PGCEA.
<b>January 29, 2024 (Monday)</b>	Voting begins @ 9:00 am. Emails containing instructions and ballot links will be sent to all members via their personal email addresses on file with PGCEA.  A ballot link will be placed on the PGCEA website.
<b>February 16, 2024 (Friday)</b>	<b>Voting ends at 5:00 pm</b> , the deadline for all election ballots.
<b>February 20, 2024 (Tuesday)</b>	NECC meets to validate the election results.  Financial statement forms detailing campaign expenses must be delivered to the NECC no later than 5:00 pm.  Email financial statements to <a href="mailto:neccchair@pgcea.org">neccchair@pgcea.org</a> or deliver them to the PGCEA NECC at 8008 Marlboro Pike, Forestville, MD 20747
<b>February 26, 2024 (Monday)</b>	NECC Announce Election Results on the PGCEA website and announced Representative Council.
<b>February 26 –March 15, 2024</b>	Run off election are held <b>if necessary</b> . Run off election results are verified and announced on March 19, 2024
<b>April 2024</b>	NECC Year-end planning meeting .
